Player Waiver & Release of Liability and Indemnification Agreement

I, the undersigned player, acknowledge, agree and understand that:

1. Voluntarily and of my own free will, elect to participate in the Spotswood Adult Recreational Pick-Up League (SARPUL) of the Spotswood Soccer Club (SSC). I acknowledge that participation in the sport of soccer is dangerous to me and to other players and may result in serious injury or death. Furthermore, I agree that I am in good health and proper physical condition to participate in the SARPUL and SSC.
2. I acknowledge and fully understand that there are certain risks and hazards involved in participating in the SARPUL and SSC and that may result in injury or death to me or other players including, but not limited to those hazards associated with, playing conditions, equipment, and other participants.
3. I understand that the very nature of the sport of soccer is hazardous and risky, including, but not limited to, the acts of running, jumping, stretching, sliding, diving, kicking, and collisions with other players and with stationary objects, all of which can cause serious injury or death to me and other players.
4. I willingly agree to comply with the stated and customary terms and conditions for participation in the SARPUL and SSC.
5. I acknowledge that I am at least 20 years of age.
6. I understand that the SARPUL and SSC does not maintain liability insurance for accident, personal injury, or other insurance, which would protect me in the event of any accident, death, or injury occurring to me during or in connection with the activities, but that such insurance is the responsibility of the undersigned player.
7. I agree that before participating in any activity associated with the SARPUL and SSC, I will inspect the facilities and equipment to be used, and if I believe anything to be unsafe, I will immediately advise a representative of the SARPUL or SSC of such condition(s) and refuse to participate.

Further, I, the undersigned player, agree that in consideration for the right to play in the SARPUL of the SSC and in consideration for permission to play:

1. I voluntarily elect to accept and assume all risks of injury incurred or suffered by me, whether arising from the negligence of the SARPUL, SSC, or otherwise, while practicing or playing as a member of the league, while serving in a non-playing capacity as a league member during practice or play by other players in the league, and while on or upon the premises of any and all of the activities arranged for by my team or league for practice or play.
2. I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, hereby release, indemnify, discharge and agree not to sue the SARPUL, SSC or their owners, officers, agents, servants, associations, employees, affiliates, or any person or entity connected with the SARPUL and SSC for any claim, damages, costs or cause of action which I have or may in the future have as a result of injuries or damages sustained or incurred by me from whatever cause including but not limited to the negligence, breach of contract or wrongful conduct of the parties hereby released.

I ACKNOWLEDGE THAT I HAVE READ AND THAT I UNDERSTAND EACH AND EVERY ONE OF THE PROVISIONS IN THIS WAIVER & RELEASE OF LIABILITY AND INDEMNIFICATION AGREEMENT AND AGREE TO ABIDE BY THEM. I ALSO UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND SIGN IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT.
